Acknowledgments. In consideration of the Gift, the Board of Trustees (Board) of the Jamestown Philomenian Library (Library) will acknowledge the Naming Gift (Naming) at a specific location (insert area or location to be named, and then the new name for that area). Before the Naming is erected, the Donor shall conclude all timely pledge payments. Subject to this Agreement, the Naming will last for 25 years, approximately the useful life of the named space.

Termination of Naming. In addition to any rights and remedies available at law, the Board may terminate this Agreement and all rights and benefits of the Donor hereunder, including the Naming.

1. In the event of any default in payment of the Gift as provided in this Agreement, or
2. In the unlikely event the Board determines in its reasonable and good faith opinion that circumstances have changed such that the Naming chosen by the Donor would adversely impact the reputation, image, mission or integrity of the Library in the event of a continuation of the Naming provided herein.

Upon such termination of this Agreement and/or the Naming hereunder, the Board and the organization shall have no further obligation or liability to the Donor and shall not be required to return any portion of the Gift already paid. The Board, however, may in its sole and absolute discretion determine an alternative recognition for the portion of the Gift already received.

Modification of Naming. If during the useful life of the Library, the Library is transferred or conveyed from the organization, closed, deconstructed, destroyed or severely damaged, significantly renovated, upgraded, or modified; relocated, or replaced, then the Naming will cease.
